The Digital Account is a multi-currency bank account with geographic coverage in national territory, which allows you to manage your company's treasury resources quickly, maintaining balances in different currencies: pesos, US dollar, Canadian dollar, euro, sterling pound, Swiss franc, Swedish krona, and yen.





Access to Monex Digital Banking



Pays interest when the average monthly balance exceeds \$50 thousand pesos.

### Requirements to open the account:

- Corporate information of the legal entity.
- Proof of updated and complete tax status (Not older than five years).
- Active FIEL.
- Proof of address of the client, not older than three months.
- Current and legible official identification of the legal representatives or attorneys-in-fact and designated participants.
- IDs, proof of address (national and foreign when applicable and considered high risk), RFC, CURP, TIN (when applicable), telephone, mail, and occupation of the real owners.

<sup>\*\*</sup>In case any of the representatives is a foreigner, a Migratory Form, Passport, and proof of address valid of no more than three months are required.
