

Monex Pro Cycling Teams sends teams to the UIC

- Cycling teams sponsored by Grupo Financiero Monex will participate in the mountain biking (MTB) and sub-23 categories in competitions of the Union Cycliste Internationale (UCI).

Mexico City, May 11, 2021.- Through the A.R. Pro Cycling Teams Program, nine young cyclists in the sub-23 category and eight mountain bikers (MTB) will participate in competitions by the Union Cycliste Internationale, the leading international organization of bicycling athletes, which for the first time history is officially registering three teams from A.R. Monex Pro Cycling.

The sub-23 category team is made up of Jorge Ernesto Valles, from Durango; Edgar David Cadena Martínez, Carlos Mier y Terán Chambón and Christopher Hans Torres Ramírez, from Mexico City; Leonardo Rafael Zavala Pantoja, from Guanajuato; Jorge Ramírez Flores and Miguel Arroyo Rosario, from Puebla, and the brothers José Armando and José Eduardo Miralrío Jaramillo, from Valle de Bravo, State of Mexico.

In women's road cycling, Grupo Financiero Monex is sponsoring four Mexican competitors in the track and road disciplines, a category dominated by young cyclists between 20 and 30 years old. The group is led by Ariadna Gutiérrez Arsaluz, from Huixquilucan, State of Mexico; followed by Julieta Lledias Villegas, from Monterrey; Andrea Ramírez Fregoso, from Guadalajara, and Lizbeth Yareli Salazar Velázquez, from Culiacán.

The young competitors in mountain biking (MTB) are Isaac del Toro Romero, from Baja California; Diego Arreola Dimas, from Durango; Bruno Camarena de León, from Jalisco; Nils Daniel Gutiérrez Guzmán, from Guanajuato; José Antonio Escárcega Mendizábal, from Hidalgo; Carlos Alfonso García Trejo, from Coahuila, and brothers José Juan and José Antonio Prieto de Luna, from Aguascalientes.

All three teams signed up with the Italian and San Marino Cycling Federation to compete in Europe under the best conditions possible, while continuing to represent Mexico.
